



### TERMS AND CONDITIONS:

1. The participants should produce their identity card before paying the caution deposit.
2. Rs 5000/- (through cash) to be paid as caution deposit by each participants
3. 50% cash should be deposited on the spot by the bidder on the bidding amount coated in the public auction. Remaining balance 50% cash should be deposited within 7 days.
4. The successful bidders should pay GST at rate of 18% for Road Worthy vehicle & scrap vehicles they should also paid parking fee to APSRTC, subject to a maximum of RS.750/-.
5. Wherever the successful bidder, wants to use his vehicle, purchased in public auction, categorized as Road Worthy vehicle by this authority, as a Road Worthy vehicle.
6. A vehicle categorized as scrap, by the under signed, shall in no case the allowed to ply on road on their ownership will not be transfer in R.C.
7. This authority is having powers to cancel the public auction and to reject the participation of the any bidder.
